



Low Voltage SPDT Analog Switch 2:1 Mux/Demux Bus Switch

Description

The DIODES PI5A3157B is a high-bandwidth, fast singlepole double-throw (SPDT) CMOS switch. It can be used as an analog switch or as a low-delay bus switch. Specified over a wide operating power supply voltage range, 1.65V to 5.5V, the PI5A3157B has a maximum ON resistance of 12 Ω at 1.65V, 9 Ω at 2.3V & 6 Ω at 4.5V.

Break-before-make switching prevents both switches being enabled simultaneously. This eliminates signal disruption during switching.

The control input, S, is independent of supply voltage.

PI5A3157B is an improved direct replacement for the NC7SB3157.










Test Circuits and Timing Diagrams




Figure 2. AC Waveforms




Figure 3. Break Before Make Interval Timing




Figure 4. Charge Injection Test




Figure 5. Off Isolation




Figure 7. Channel Off Capacitance




Figure 6. Crosstalk




Figure 8. Channel On Capacitance






Figure 9. Bandwidth
